

## **SITE TERMS OF USE**

JNR Site and Services are created and operated to manage and host Incentive and Rewards Programs (the "Program(s)") for its clients. These Programs are intended to target any group or combination of client customers, employees, dealers, resellers, brokers, or any other associated group related in business or affiliations to a particular JNR client. Further information regarding a particular Program may be provided in greater detail to Program participants. Please note that if you are a cardholder, these Terms of Use are not intended to, and do not, modify or alter the terms of the Cardholder Agreement, as applicable, which governs the use of the prepaid card (the "Card"). In the event of a conflict between this document and the Cardholder Agreement, the Cardholder Agreement associated with the Card program will be held as the governing document for all disputes. By accessing or using the Services, whether via computer, mobile device or other technology, you represent that you are 18 years of age or older and you have read and agree to be bound by these Terms of Use in their entirety and all applicable laws, rules and regulations governing your use of the Services. These Terms of Use may be amended by posting a new version on our Services which version will be effective upon posting. If you do not agree to the new version of these Terms of Use, do not use the Services.

### **Privacy**

To access the Services or some of the resources offered, you may be asked to provide certain personal information and non-personal information.
